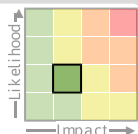
The flood risk is VERY LOW for the next five days despite unsettled weather throughout the week.

Assessment of flood risk



Coastal/Tidal

Along exposed north-west facing coasts of Devon and Cornwall, the Isles of Scilly and Bristol Channel minor coastal flooding impacts are possible. In these locations high water levels may coincide with large waves and strong winds. Minor impacts are also possible along parts of the Wye and Usk estuaries due to high tidal water levels.

High spring tide levels are also expected along eastern coasts today and while localised minor coastal flooding impacts are possible, they are a very low likelihood.



Rivers

Periods of rain or showers, some of which may be heavy, are expected over the next five days, particularly on Friday and into Saturday when there is a very low likelihood of seeing some localised minor river flooding impacts from widespread persistent rain.



Surface water

On Friday and into Saturday there is a very low likelihood of seeing some localised minor surface water flooding impacts from widespread persistent rain.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
