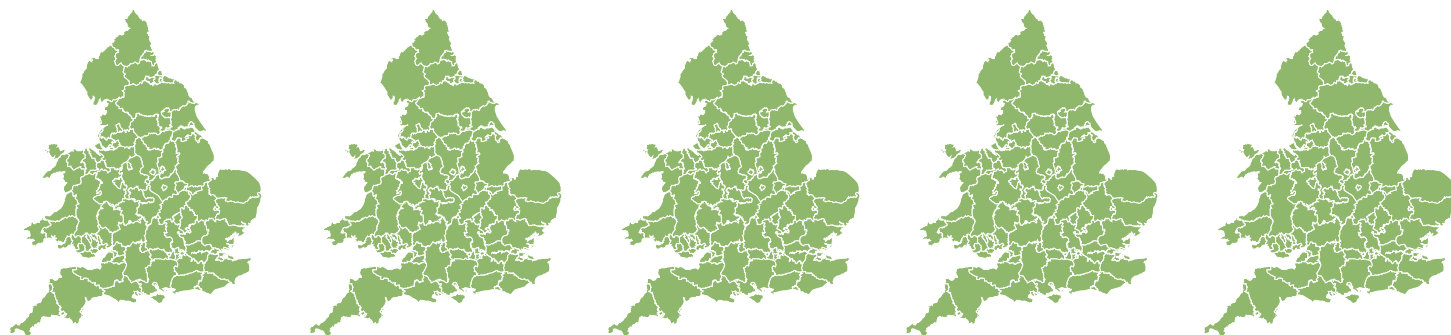

Localised minor river and surface water impacts are possible from rainfall Monday/Tuesday, and from potentially heavy showers on Wednesday/Thursday, although none are currently expected. The overall flood risk remains VERY LOW.

Assessment of flood risk



Surface water

The surface water flood risk is VERY LOW for the next five days.

During Monday and into Tuesday spells of prolonged, heavy rainfall are expected across the west of England and Wales, especially over high ground. Some minor surface water impacts are possible, but not currently expected.

On Wednesday heavy, thundery showers may develop across parts of England with isolated minor surface water impacts possible, but not expected. This risk may continue into Thursday morning in the far south-east.



Rivers

The river flood risk is VERY LOW for the next five days.

During Monday and into Tuesday spells of prolonged heavy rainfall are expected across the west of England and Wales, especially over high ground. Some minor river flooding impacts are possible locally, but are not currently expected.

On Wednesday heavy, thundery showers may develop across parts of England with isolated minor river impacts possible in small urban catchments. However, impacts are not currently expected. This risk continues into Thursday morning in the far south-east.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
