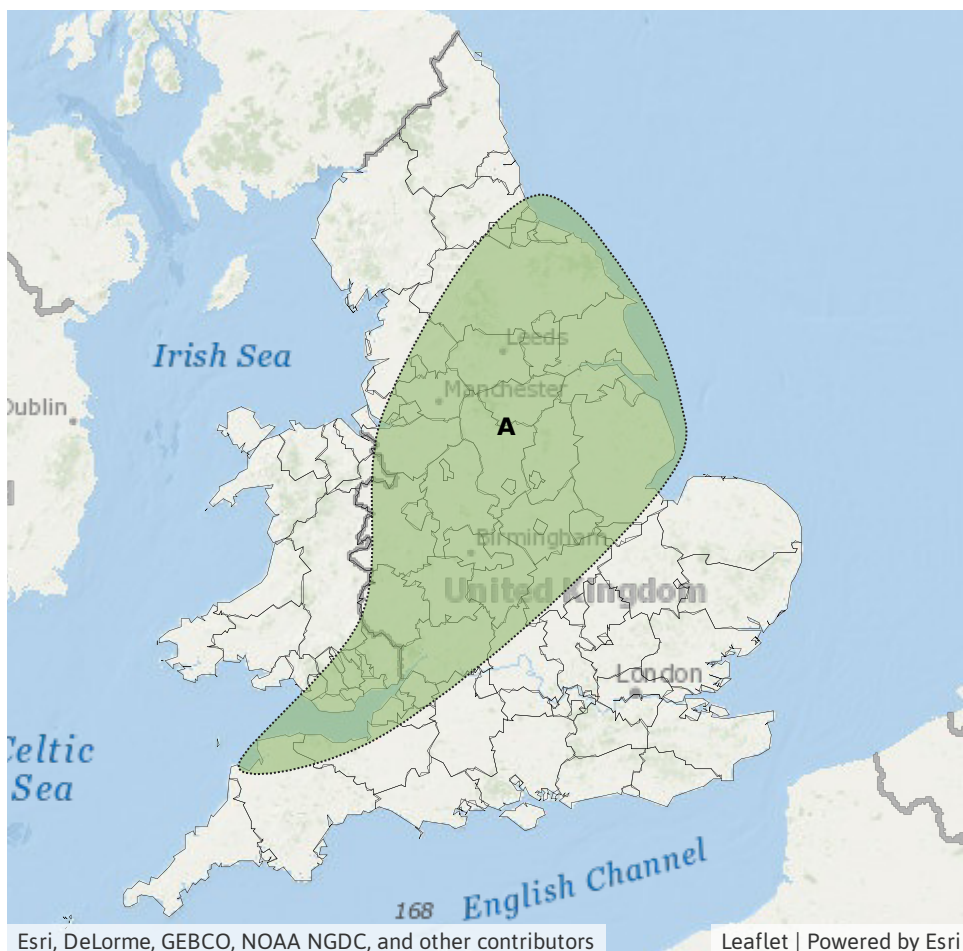
Likelihood VERY LOW

Assessment of flood risk



Surface water

Local minor surface water flooding impacts on Thursday are possible but not expected. This is as a result of heavy showers that may form into bands on Thursday evening and into the night.



Rivers

The river flood risk is VERY LOW for the next five days. Some rivers across north-east England remain high today following rainfall overnight, however flood impacts are minimal.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
