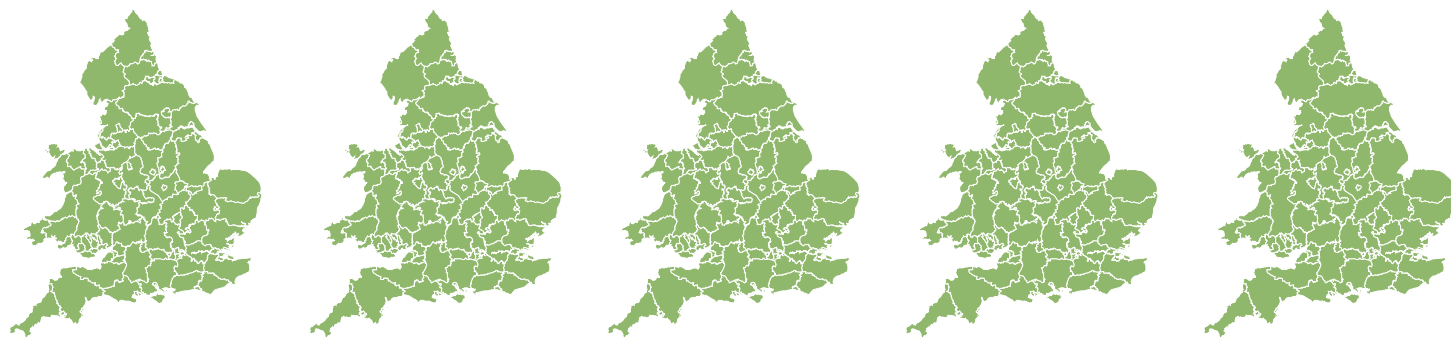

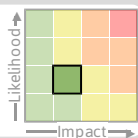
Isolated minor surface water flooding impacts are possible across the south of England and Wales on Tuesday and possible but not expected across parts of England and Wales at other times. The overall flood risk remains VERY LOW.

Impact **MINOR**

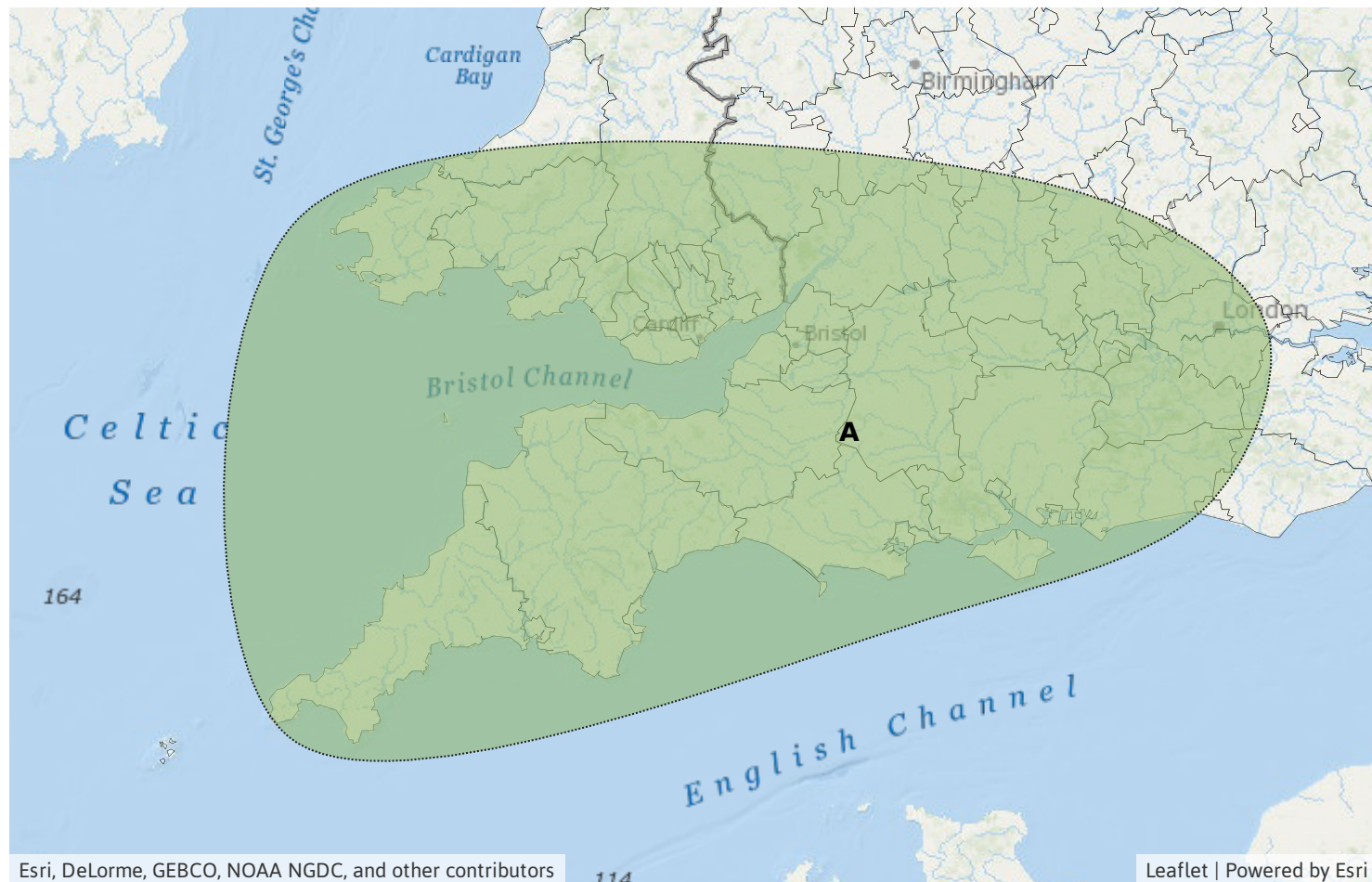
Likelihood **LOW**

Likely duration 1 Day

Thunderstorm potential. Urban areas most at risk during afternoon and evening.



Assessment of flood risk



Surface water

Isolated minor surface water flooding impacts are possible across parts the south of England and Wales on Tuesday. Refer to Specific Area of Concern Map 1.

Isolated minor surface water flooding impacts are possible but not expected in south east England today (Sunday), east and central parts of England and Wales on Monday, other parts of the south of England on Tuesday and across parts of England and Wales on Thursday. There is the potential for isolated heavy thunderstorms forming during the afternoon and evenings. Urban areas are most at risk.



Rivers

The river flood risk is VERY LOW for the next five days.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
