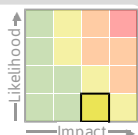
Isolated significant surface water and river flooding impacts are possible, but not expected, across parts of England today. The overall flood risk is LOW.

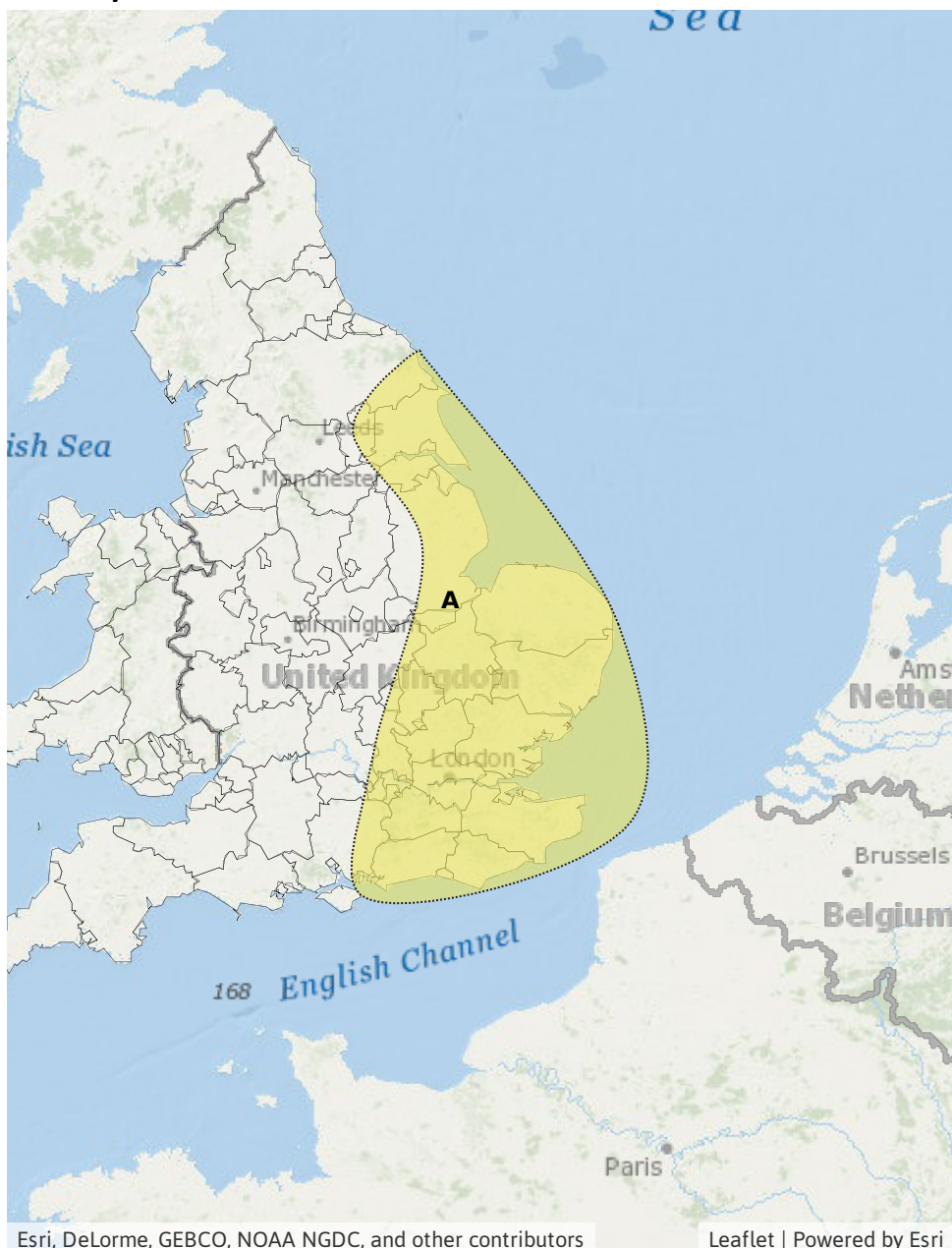

Assessment of flood risk



Surface water

Across parts of central, southern and eastern England today (Thursday) isolated significant surface water flooding impacts are possible, but not expected. Refer to Specific Area of Concern Map 1. Urban areas are most at risk.



Rivers

Across parts of central, southern and eastern England today (Thursday) isolated significant river flooding impacts are possible, but not expected. Refer to Specific Area of Concern Map 1. Urban areas and other fast responding water courses are most at risk.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days despite a period of high astronomical tides this weekend.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
