The overall flood risk remains VERY LOW for the next five days. Minor impacts are possible but not expected from river and surface water flooding across England and Wales on Tuesday.

Assessment of flood risk



Surface water

The surface water flood risk is VERY LOW for the next five days.

Minor impacts are possible but not expected on Tuesday with the potential for thundery downpours to cause surface water flooding especially in urban areas across England and Wales.



Rivers

The river flood risk is VERY LOW for the next five days.

Minor impacts are possible but not expected on Tuesday with the potential for thundery downpours to cause rapid river response, especially in small, urban catchments across England and Wales.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days despite a period of high astronomical tides this weekend.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
