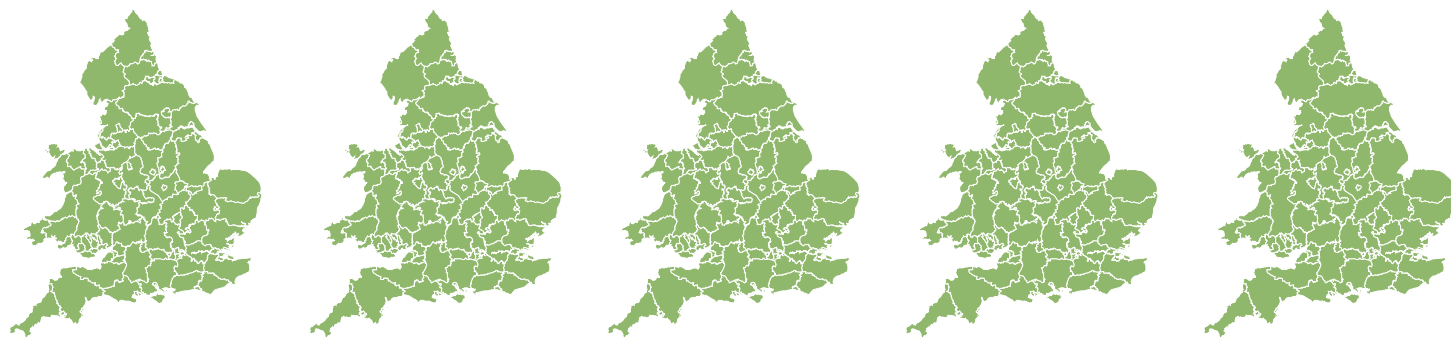

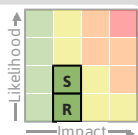
Isolated minor surface water flooding impacts are possible in parts of central England and Wales on Saturday. The overall flood risk remains VERY LOW.

Impact **MINOR**

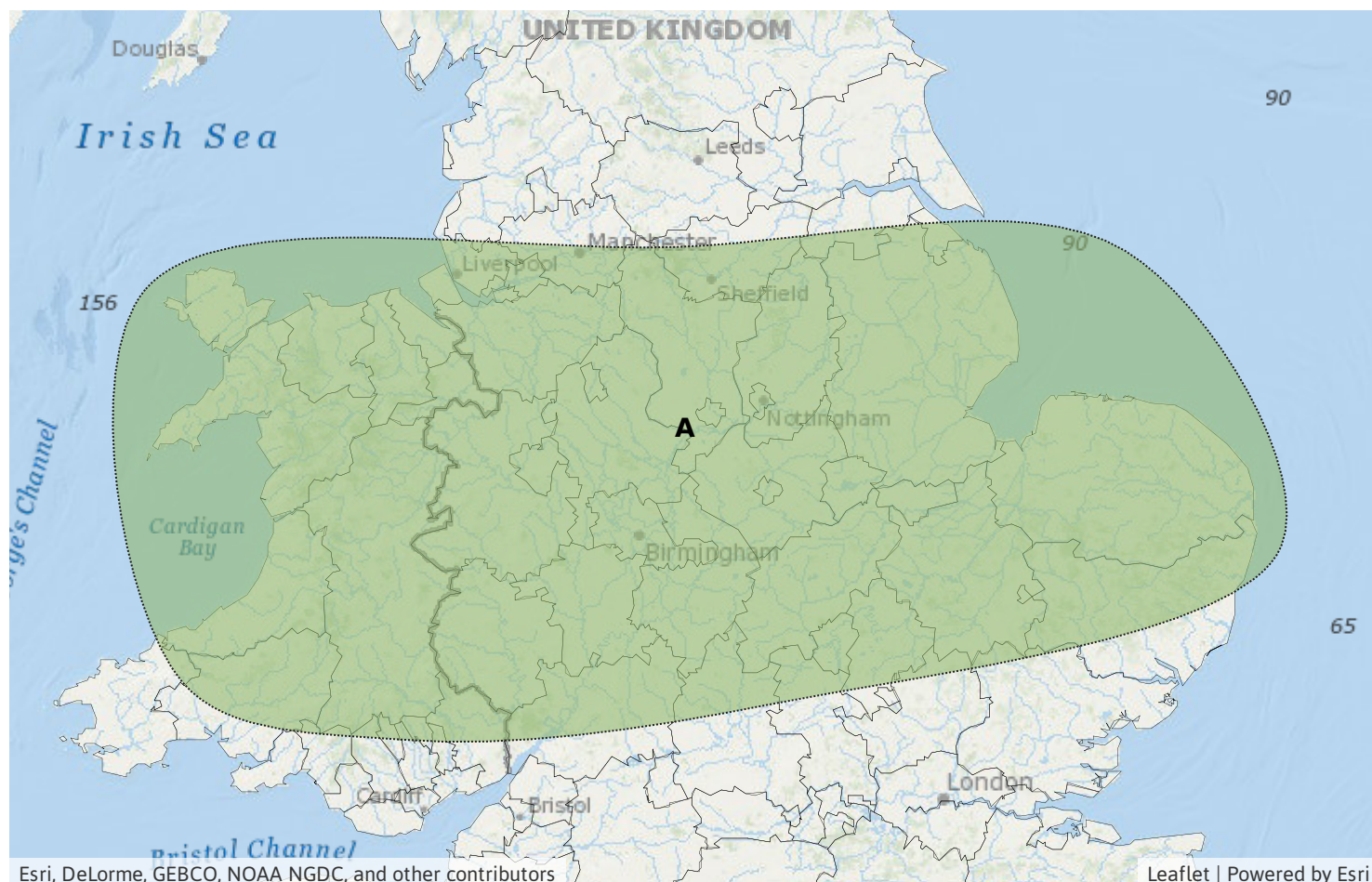
Likelihood **LOW**



Source River Surface

Likely duration 1 Day

Urban areas most at risk. Thunderstorms moving from west to east from early Sat.



Assessment of flood risk



Surface water

The surface water flood risk is VERY LOW for the next five days, despite periods of heavy showers and rain at times.

Isolated minor surface water flooding impacts are possible in parts of central, north and east England and Wales on Saturday due to scattered heavy thunderstorms. The main risk area moves east through the day (Area A on Area of Concern Map 1).



Rivers

The river flood risk is VERY LOW for the next five days, despite periods of heavy showers and rain at times.

Isolated river flooding impacts are possible but not expected on some fast responding or small urban catchments in Area A on Area of Concern Map 1, if affected by heavy thunderstorms.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
