Minor surface water, river and coastal flooding impacts are possible at times over the next three days. The overall flood risk remains VERY LOW.

Assessment of flood risk



Surface water

Minor surface water flooding impacts are possible today (Saturday) and again on Sunday into Monday. This is as a result of heavy showers and longer spells of rain. Urban areas are most at risk.

The overall surface water flood risk remains VERY LOW for the next five days.



Rivers

Minor river flooding impacts are possible but not expected in parts of the north of England today (Saturday) and again on Sunday into Monday. This is as a result of heavy showers and longer spells of rain. Smaller, faster responding rivers and urban watercourses are most prone.

The overall river flood risk remains VERY LOW for the next five days.



Coastal/Tidal

Minor impacts are possible but not expected later on Sunday and into Monday morning around the south-west coast of England. This is due to gale force winds and large waves resulting in instances of wave over-topping. Otherwise, impacts are expected to be minimal.

The overall coastal/tidal flood risk remains VERY LOW for the next five days.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
