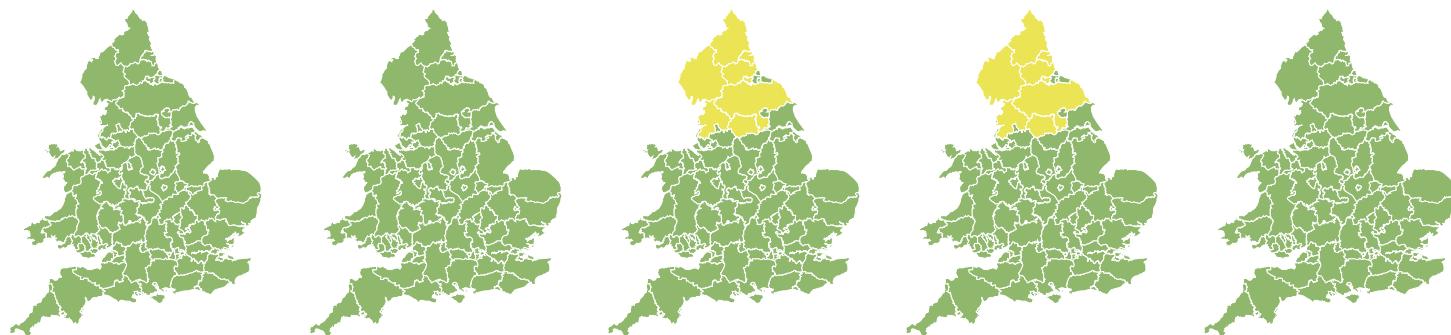

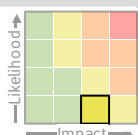
Significant river flooding impacts are possible but not expected in parts of the north of England on Wednesday and Thursday. The overall flood risk is LOW.

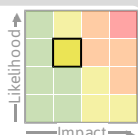

Source River Surface

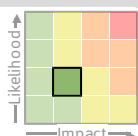
Likely duration 2 Days

Impact **MINOR**

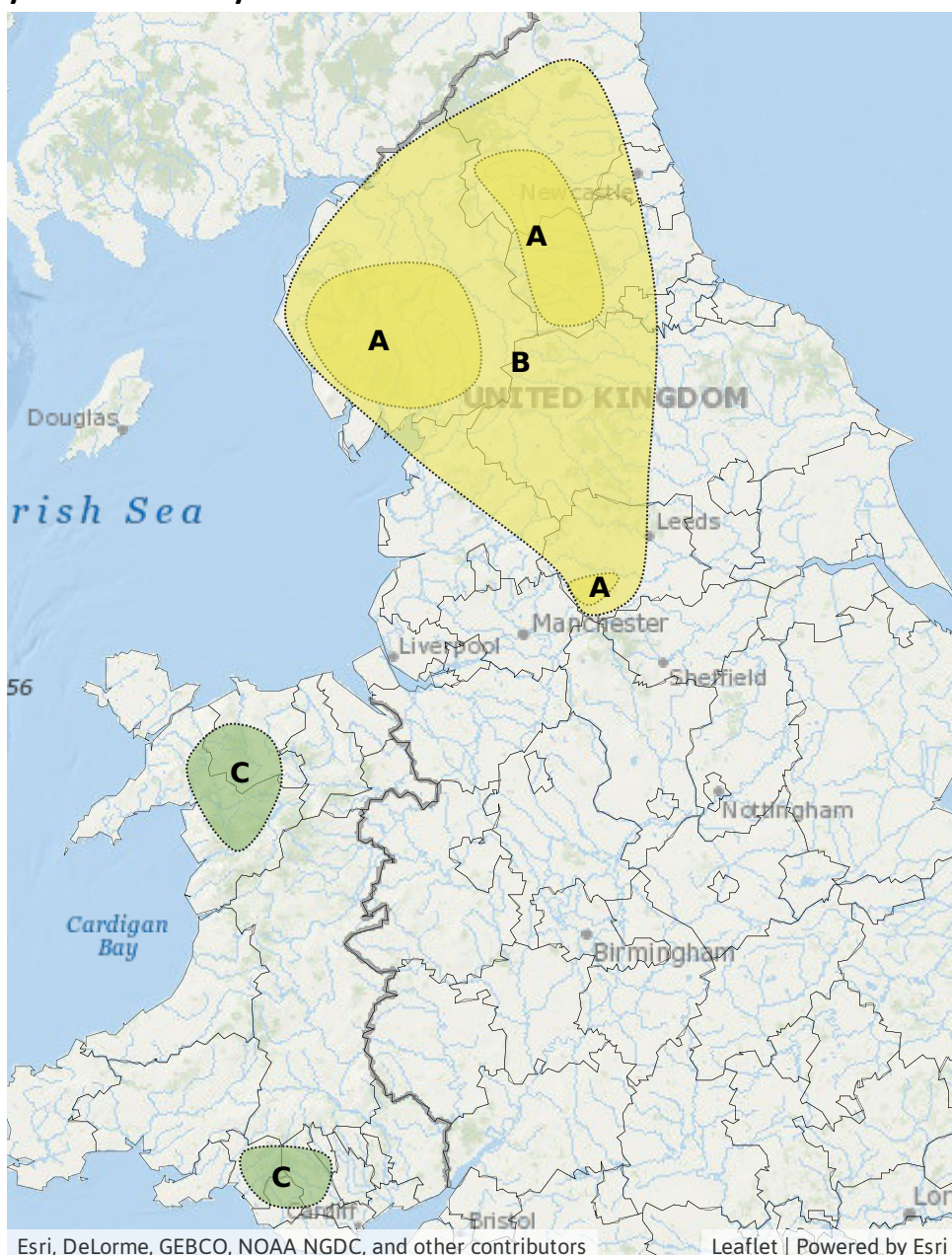
Likelihood **LOW**

Assessment of flood risk



Rivers

Significant river flooding impacts are possible but not expected across parts of the north of England from Wednesday afternoon to early Thursday due to heavy and persistent rain falling across high ground in these areas. See Risk Areas A in the Specific Areas of Concern Map.

Minor river flooding impacts are probable for the same period in Risk Area B. In Risk Areas C, minor river flooding impacts are also possible.

The overall river flood risk is LOW.



Surface water

Minor surface water flooding impacts are probable across parts of the north of England from Wednesday afternoon to early Thursday due to heavy and persistent rain falling across high ground in these areas. See Risk Area B in the Areas of Concern Map. This brings a LOW surface water flood risk overall.

Across north-west Wales minor surface water flooding is possible during the same period, see Risk Areas C in the Areas of Concern Map.



Coastal/Tidal

The coastal flood risk is VERY LOW for the next five days.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
