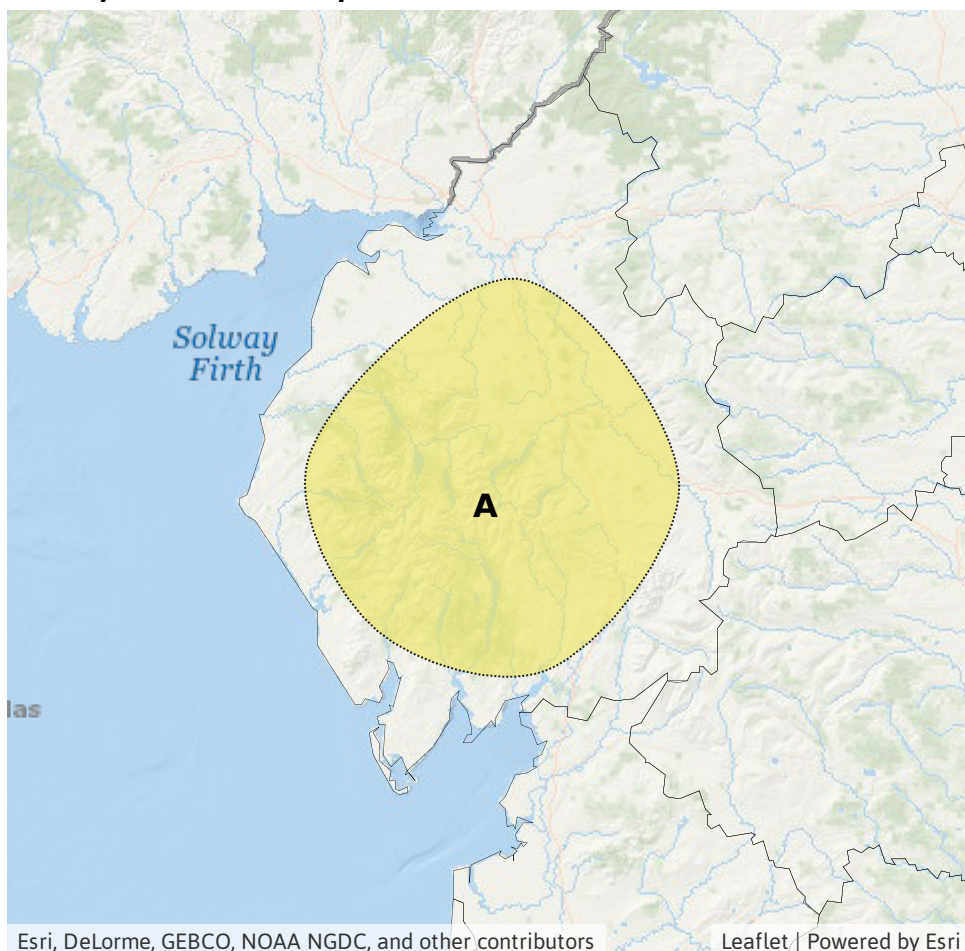

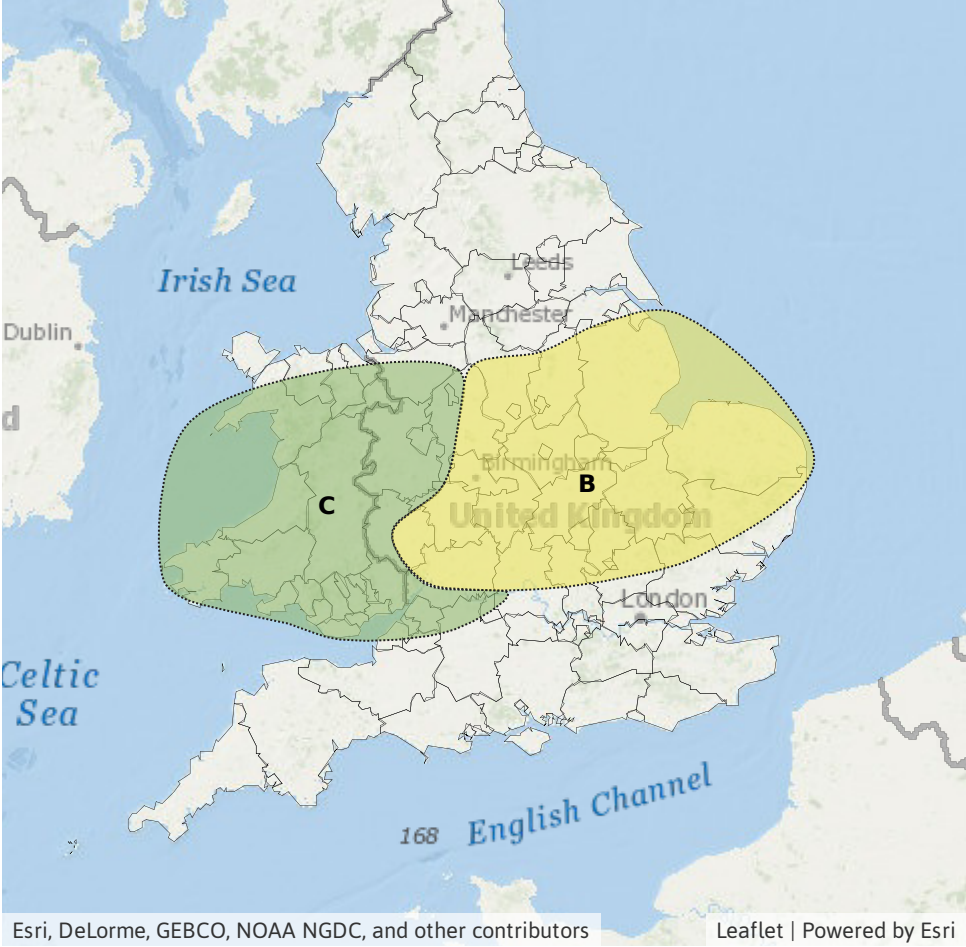

Assessment of flood risk



Surface water

Minor surface water flooding impacts are probable today (Monday) in Area A in Specific Area of Concern Map 1, due to locally heavy rain on already saturated ground. Outside of this area, minor surface water flooding impacts are possible but not expected across the north of England.

On Tuesday and Wednesday minor surface water flooding impacts are probable in Area B in Specific Area of Concern Map 2, due to widespread rain and some snow. Minor surface water impacts are also possible in Area C.



Rivers

Minor river flooding impacts are possible in Area A in Specific Area of Concern Map 1 today (Monday), due to locally heavy rain on already saturated ground. Outside of this area, minor river flooding impacts are possible but not expected across the north of England.

On Tuesday and Wednesday river flooding impacts are probable in Area B in Specific Area of Concern map 2, due to widespread rain and some snow. Minor river flooding impacts are also possible but not expected in area C.



Coastal/Tidal

The coastal flood risk is VERY LOW for the next five days.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
