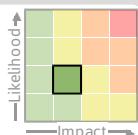

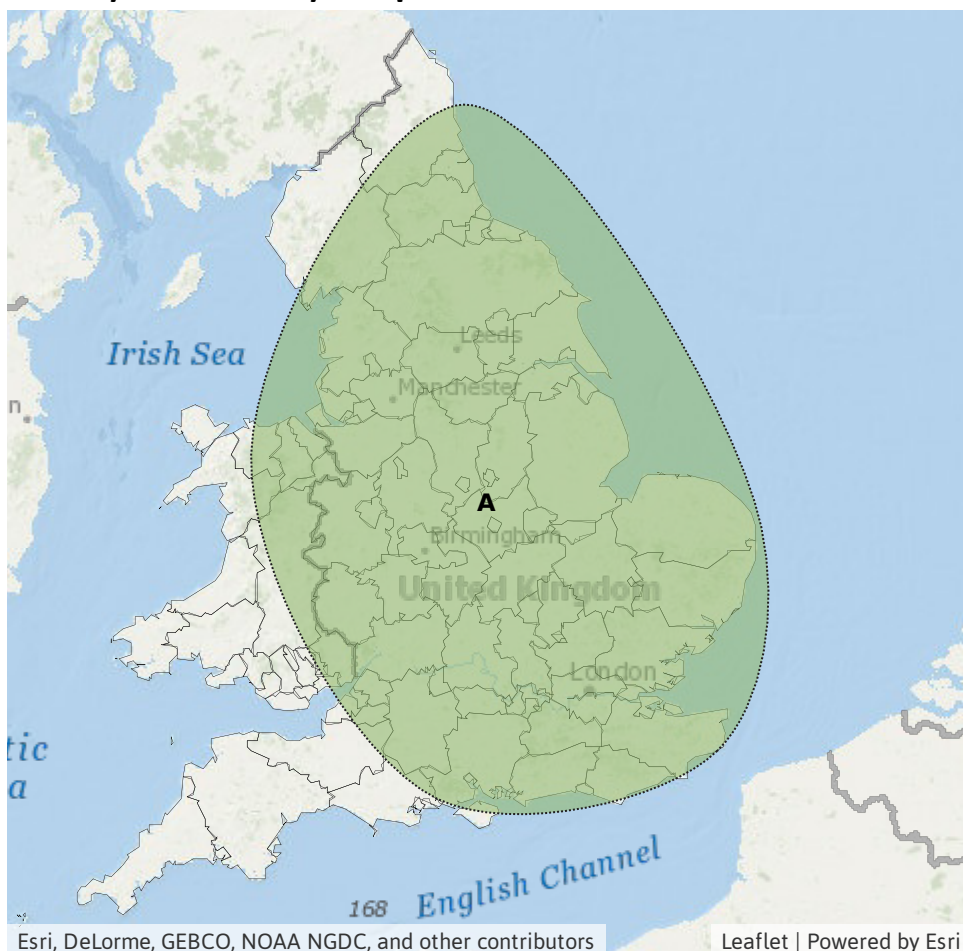

Assessment of flood risk



Surface water

Minor surface water flooding impacts are possible from Saturday afternoon and overnight into Sunday for much of England and Wales, due to heavy, thundery showers - see Specific Area of Concern Map 1. Showers are most likely to develop through central and western parts during Saturday afternoon, moving gradually east or north-east overnight and during Sunday morning. Any impacts are expected to be localised.

The overall surface water flood risk is VERY LOW for the next five days.



Rivers

The river flood risk is VERY LOW for the next five days, despite the possibility of heavy, thundery showers on Saturday afternoon and overnight into Sunday. Any river flooding impacts are expected to be minimal and limited to small, fast responding urban catchments.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Groundwater levels remain high across parts of Hampshire and West Berkshire, with some ongoing minimal impacts. Levels are not expected to rise further.

Groundwater levels are high in North Yorkshire and East Riding of Yorkshire and are expected to slowly rise, but in the absence of further widespread rain over the next few days, levels should begin to plateau and then slowly decline. No groundwater flooding impacts are currently expected.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
