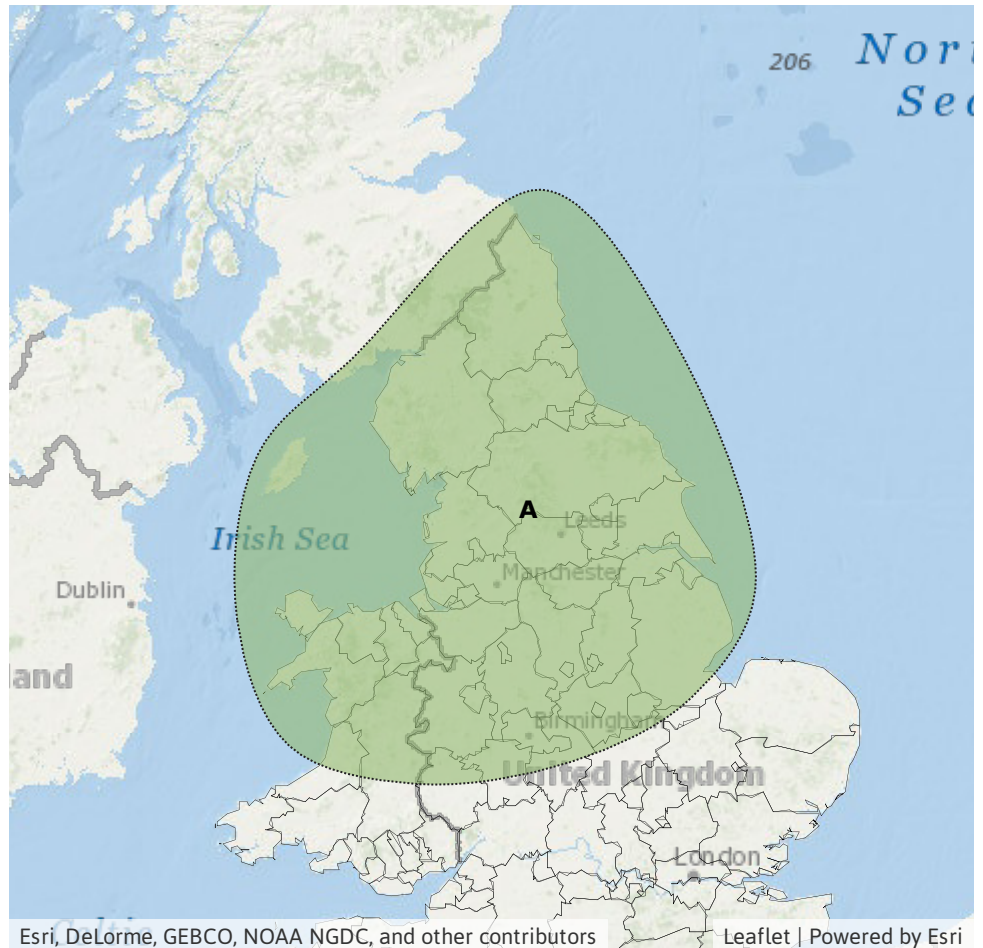
Minor surface water flooding impacts are possible in parts of England and Wales on Monday and Tuesday. The overall flood risk is VERY LOW.

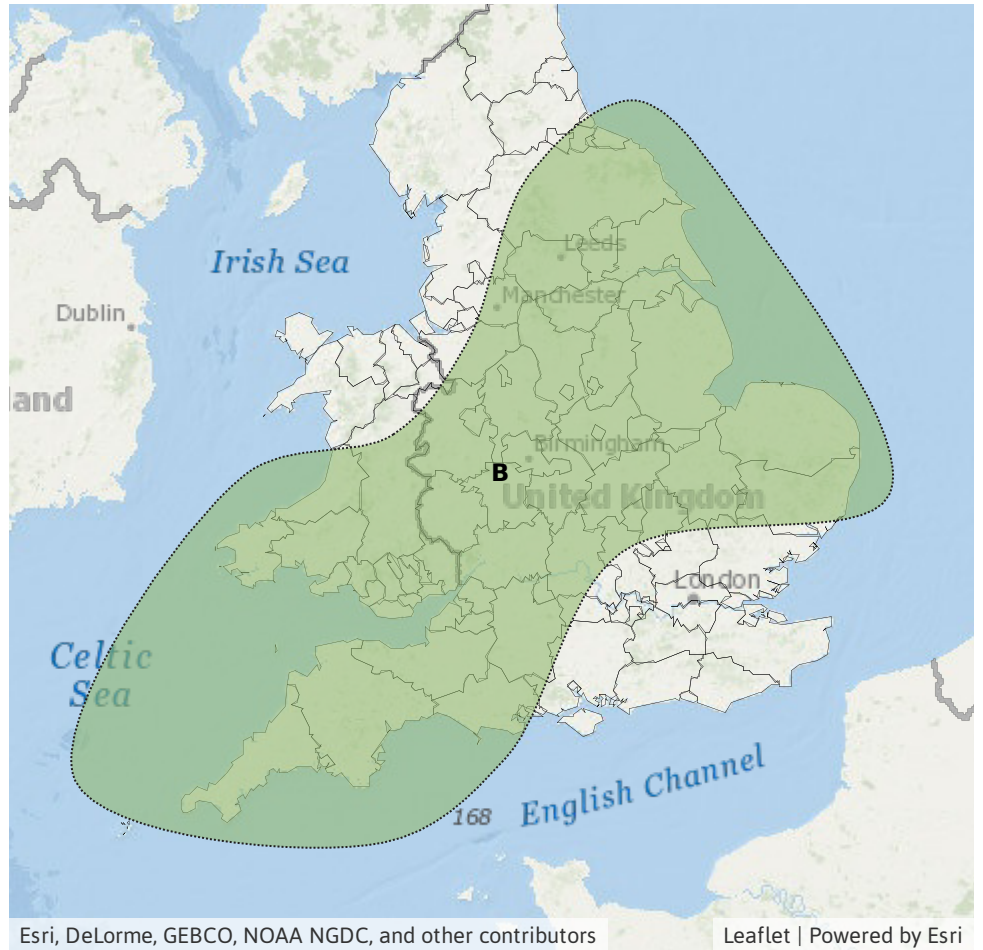

Some locally heavy showers. Urban areas most at risk.



Assessment of flood risk



Surface water

The surface water flood risk is VERY LOW.

Minor surface water flooding impacts are possible in Areas A and B in Specific Areas of Concern Maps 1 and 2 on Monday and Tuesday respectively. This is due to the risk of locally heavy showers and thunderstorms.

Some minor surface water flooding impacts are possible but not expected across parts of the south-east of England and East Anglia during Wednesday as a result of further locally heavy showers.



Rivers

The river flood risk is VERY LOW.

Minor river flooding impacts are possible but not expected in Areas A and B in Specific Areas of Concern Maps 1 and 2 on Monday and Tuesday respectively. This is due to the risk of heavy showers affecting small, fast responding urban catchments.

Some minor river flooding impacts are possible but not expected across parts of the south-east of England and East Anglia during Wednesday as a result of further locally heavy showers. Again, small fast responding urban catchments are most at risk.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Flood risk matrix



Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
