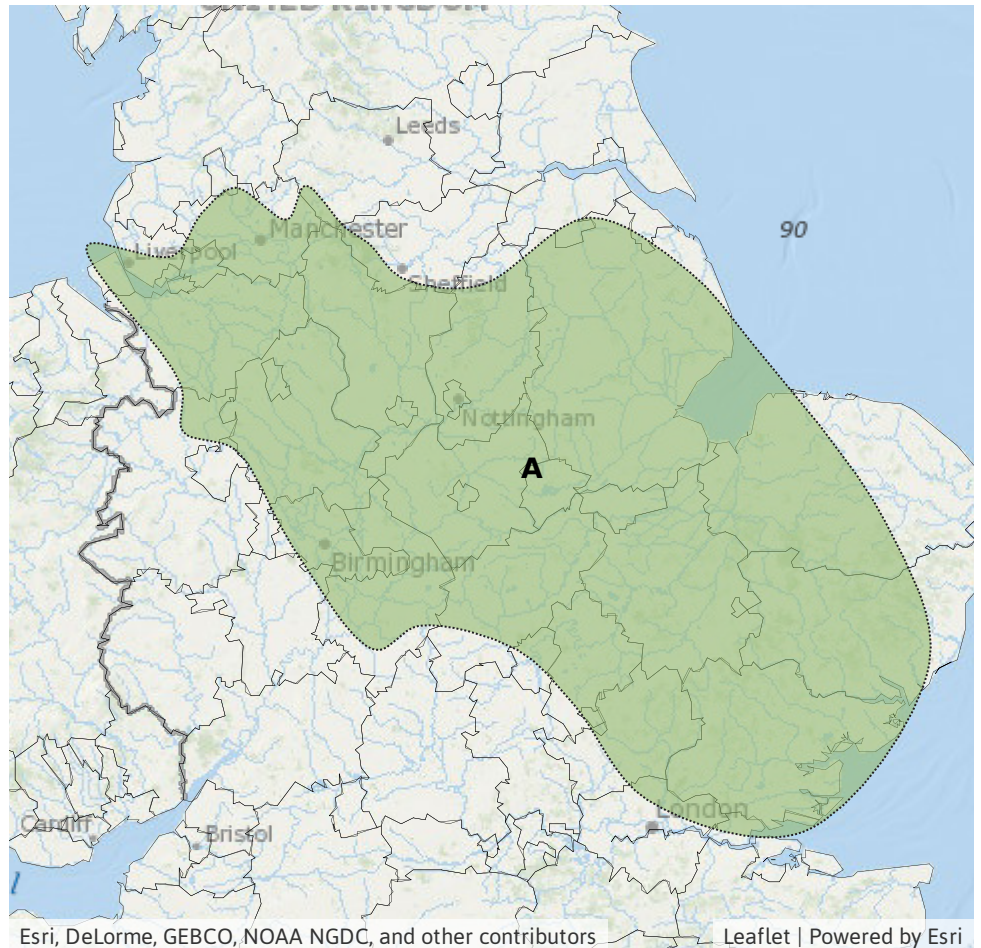
Minor inland flooding impacts are possible on Thursday in parts of the north, central and eastern England and are possible but not expected at other times elsewhere. The overall flood risk is VERY LOW.

Assessment of flood risk



Rivers

The river flood risk is VERY LOW for the next five days.

Minor river flooding impacts are possible in parts of the north of England and parts of central and east of England on Thursday. More widely minor river flooding impacts are possible but not expected across the north-east and east of England and along slower responding rivers for parts of the River Severn and River Avon in Worcestershire and Gloucestershire. Continuing minor river flooding impacts are possible but not expected going into the weekend for some slower responding rivers.

Further minor river flooding impacts are possible but not expected in the north and west of England, the Midlands and across Wales due to heavy rain and some snow melt on Saturday, Sunday and Monday.



Surface water

The surface water flood risk is VERY LOW for the next five days.

Minor surface water flooding impacts are possible but not expected in parts of the north and west of England, the Midlands and parts of Wales on Saturday, Sunday and Monday due to a combination of rainfall and snowmelt.



Groundwater

The groundwater flood risk is VERY LOW for the next five days. However, groundwater levels are high in many places, particularly in parts of the south of England.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
