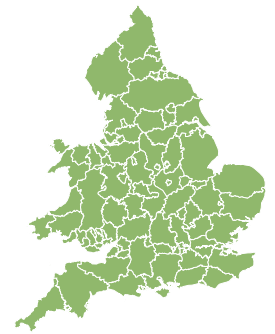
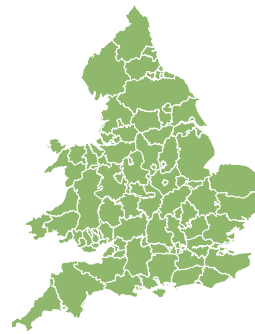

Minor inland flooding impacts possible in the north of England and possible but not expected elsewhere in Wales and northwest England on Tuesday and Wednesday. The overall flood risk for England and Wales for the next five days is VERY LOW.

Assessment of flood risk



Rivers

The river flood risk is VERY LOW for the next five days.

Localised minor river flooding impacts are possible in parts of the north of England from later today (Tuesday) and during Wednesday. Refer to the Specific Area of Concern Map for further details.

Elsewhere, in Wales and the north-west of England, localised minor river flooding impacts are possible but not expected from later today and during Wednesday.

This is due to the potential for widespread heavy rain during this period.



Surface water

The surface water flood risk is VERY LOW for the next five days.

Localised minor surface water flooding impacts are possible in parts of the north of England today (Tuesday) and during Wednesday. Refer to the Specific Area of Concern Map for further details.

Elsewhere, in Wales and the north-west of England, localised minor surface water flooding impacts are possible but not expected today and during Wednesday.

This is due to the potential for widespread heavy rain during this period.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
