


Minor inland flooding impacts are possible on Wednesday and into Thursday across parts of England and Wales. Minor coastal flooding impacts are possible from Wednesday to Friday. The overall flood risk remains VERY LOW.

Specific Areas of Concern Map 1 - Wednesday 16 and early Thursday 17 October 2024





Assessment of flood risk



The river flood risk is VERY LOW for the next five days.

Minor river flooding impacts are possible during Wednesday and into Thursday across parts of England and Wales. See Specific Areas of Concern Map 1.

Surface water

The surface water flood risk is VERY LOW for the next five days.

Minor surface water flooding impacts are possible across parts of England and Wales during Wednesday and into Thursday. See Specific Areas of Concern Map 1.

Impacts could include localised flooding from urban and fast responding smaller watercourses/catchments, drains, channels and flooding from overland flow.

🖸 Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.

Minor coastal flooding impacts are possible for parts of the South Wales coastline Wednesday and Thursday, and more widely for England and Wales on Friday. See Specific Areas of Concern Map 2 and 3.

Minor coastal flooding impacts are also possible but not expected along parts of the England coastline on Wednesday, Thursday and more widely on Friday.



The groundwater flood risk is VERY LOW for the next five days.



Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads Isolated spray/wave on coastal promenades Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads Flooding affecting individual properties Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities Possible danger to life and damage to buildings/structures Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel Widespread flooding affecting whole communities Widespread disruption or loss of infrastructure Large scale evacuation of properties possible
