


Specific Areas of Concern Map 1 - Tuesday 26 November 2024







Assessment of flood risk



The river flood risk is MEDIUM today (Tuesday).

Significant river flooding impacts are probable in parts of Northamptonshire today following heavy rainfall from Storm Bert. Minor river flooding is also expected on the River Severn and possible more widely across England and Wales. See Specific Areas of Concern Maps.

Additional minor river flooding impacts are also probable in parts of the South and East of England and possible elsewhere in parts of England and Wales later Tuesday and through Wednesday due to further heavy rain and probable on the lower River Severn until Friday. See Specific Areas of Concern Maps.



The surface water flood risk is LOW for later Tuesday and Wednesday.

Minor surface water flooding impacts are probable in parts of the South and East of England and possible elsewhere in parts of England and Wales later Tuesday and through Wednesday due to further heavy rain. See Specific Areas of Concern Maps.

Impacts could include localised flooding from urban and fast responding smaller watercourses/catchments, drains, channels and flooding from overland flow.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.

Groundwater

The groundwater flood risk is VERY LOW for the next five days.



Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads Isolated spray/wave on coastal promenades Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads Flooding affecting individual properties Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities Possible danger to life and damage to buildings/structures Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel Widespread flooding affecting whole communities Widespread disruption or loss of infrastructure Large scale evacuation of properties possible
