


Minor inland flooding impacts are probable in parts of England and Wales today and tomorrow, and are possible on Wednesday and Thursday. The overall flood risk is LOW.










Specific Areas of Concern Map 2 - Wednesday 29 and Thursday 30 January 2025

Assessment of flood risk



The river flood risk is LOW for today (Monday) and Tuesday.

Minor river flooding impacts are probable across parts of the South of England today (Monday) and tomorrow, and are possible more widely across parts of England and Wales at times this week from heavy showers and further heavy rain. See Specific Areas of Concern Maps.



Surface water

The surface water flood risk is LOW for today (Monday) and Tuesday.

Minor surface water flooding impacts are probable across parts of Wales and the South of England today (Monday) and tomorrow, and are possible across parts of the South of England on Wednesday and Thursday from heavy showers. See Specific Areas of Concern Maps.

Impacts could include localised flooding from urban and fast responding smaller watercourses/catchments, drains, channels and flooding from overland flow.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.

Minor coastal impacts are possible in parts of Dorset on Monday and into Tuesday morning due to large waves and surge. See Areas of Concern Map.

Minimal coastal impacts are also expected along some English and Welsh coasts through the next few days due to gale force winds, storm surge and large waves. Impacts may include isolated spray on low-lying roads and coastal promenades.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Minor groundwater impacts are possible but not expected in parts of the south of England from Tuesday.



Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads Flooding affecting individual properties Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel Widespread flooding affecting whole communities Widespread disruption or loss of infrastructure Large scale evacuation of properties possible
