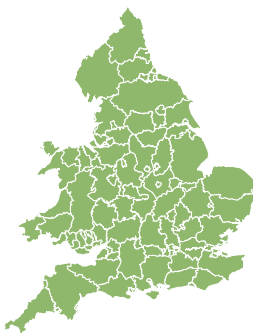

Minor inland flooding impacts are possible on Thursday and Friday across parts of England and Wales. The overall flood risk is VERY LOW.

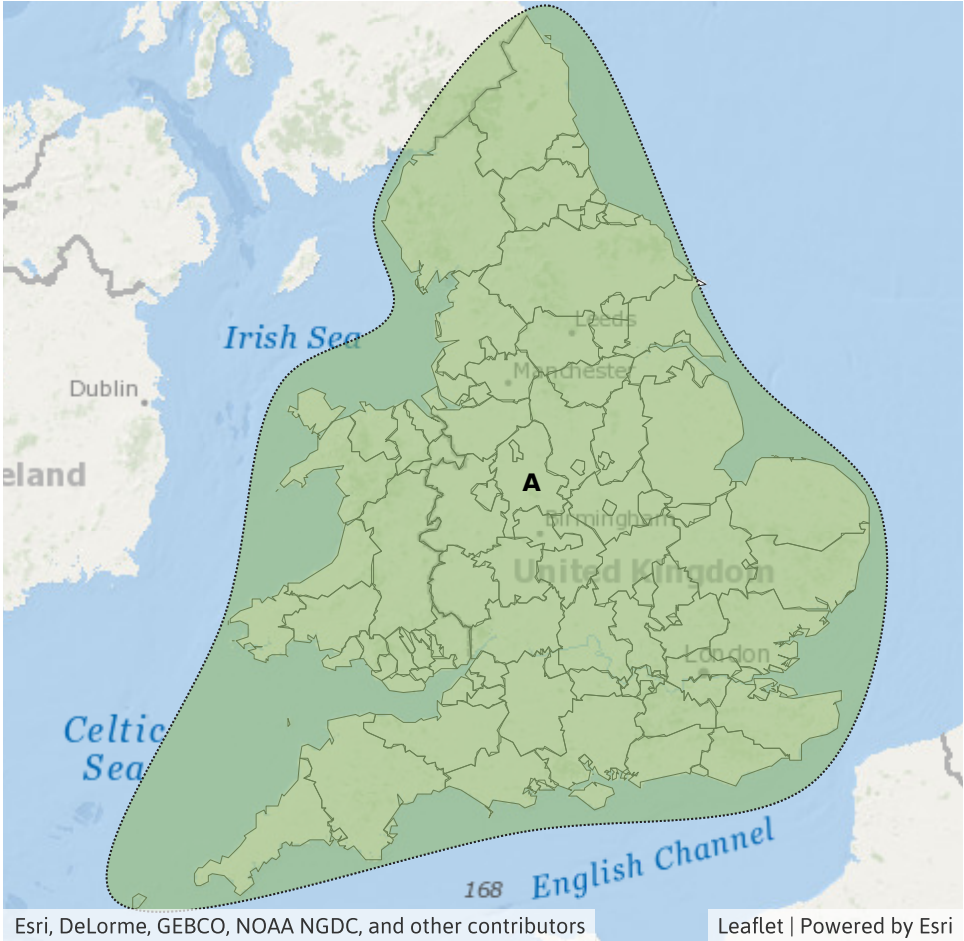
Specific Areas of Concern Map 1 - Thursday 23 and Friday 24 October 2025

Assessment of flood risk



Surface water

The surface water flood risk is VERY LOW for the next five days.

Minor surface water flooding impacts are possible in parts of England and Wales on Thursday, and into Friday. See Specific Areas of Concern Map for more details.

Minor surface water flooding impacts are possible but not expected today (Monday) in parts of England and Wales.

Impacts could include localised flooding from urban and fast responding smaller watercourses/catchments, drains, channels and flooding from overland flow.



Rivers

The river flood risk is VERY LOW for the next five days.

Minor river flooding impacts are possible but not expected in parts of England and Wales on Thursday, and into Friday. See Specific Areas of Concern Map for more details.



Coastal/Tidal

The coastal/tidal flood risk is VERY LOW for the next five days.

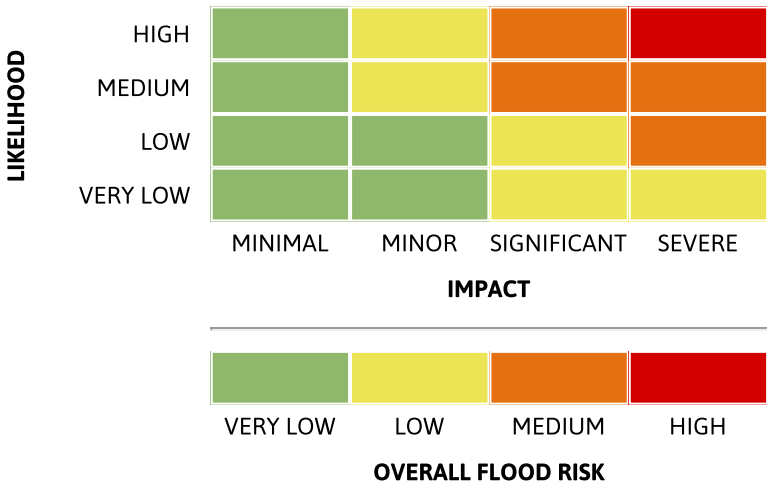
Minimal coastal flooding impacts are possible in England and Wales on Thursday and in England on Friday due to high tides and unsettled coastal conditions including large waves and storm surge. Impacts may include isolated spray on low-lying roads and coastal promenades.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Flood risk matrix



Summary of potential impacts

- MINIMAL**
Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces
- MINOR**
Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans
- SIGNIFICANT**
Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans
- SEVERE**
Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
