


Minor coastal flooding impacts are expected in the South West of England on Wednesday. Minor inland flooding impacts are probable on Tuesday and Wednesday. The overall flood risk is LOW.



### Assessment of flood risk



Coastal/Tidal

The coastal/tidal flood risk is LOW on Wednesday.

Minor coastal flooding impacts are expected in parts of South West England on Wednesday, with minor impacts possible along other coasts of England and Wales through Wednesday and Thursday. Refer to the Specific Areas of Concern Map.

Minor coastal flooding impacts are possible but not expected more widely along coasts of England and Wales from Wednesday to Friday.



### Surface water

The surface water flood risk is LOW on Tuesday and Wednesday.

Minor surface water flooding is probable in places, and possible more widely across parts of England and Wales on Tuesday and into Wednesday morning. Refer to the Specific Areas of Concern Map.

Impacts could include localised flooding from urban and fast responding smaller watercourses/catchments, drains, channels and flooding from overland flow.



The river flood risk is LOW on Tuesday and Wednesday.

Minor river flooding impacts are probable across parts of England and Wales today and Wednesday and possible more widely. Refer to the Specific Areas of Concern Map.



## Groundwater

The groundwater flood risk is VERY LOW for the next five days.



## Flood risk matrix



### **Summary of potential impacts**

#### MINIMAL

Isolated and minor flooding of low-lying land and roads Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

### **MINOR**

Localised flooding of land and roads Flooding affecting individual properties Disruption to travel and key sites in flood plans

### **SIGNIFICANT**

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

### **SEVERE**

Danger to life, severe disruption to travel Widespread flooding affecting whole communities Widespread disruption or loss of infrastructure Large scale evacuation of properties possible
