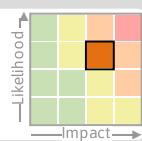

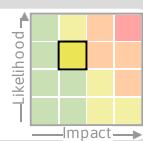

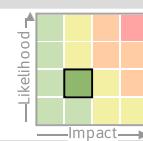

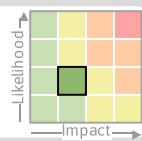

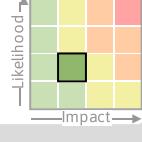

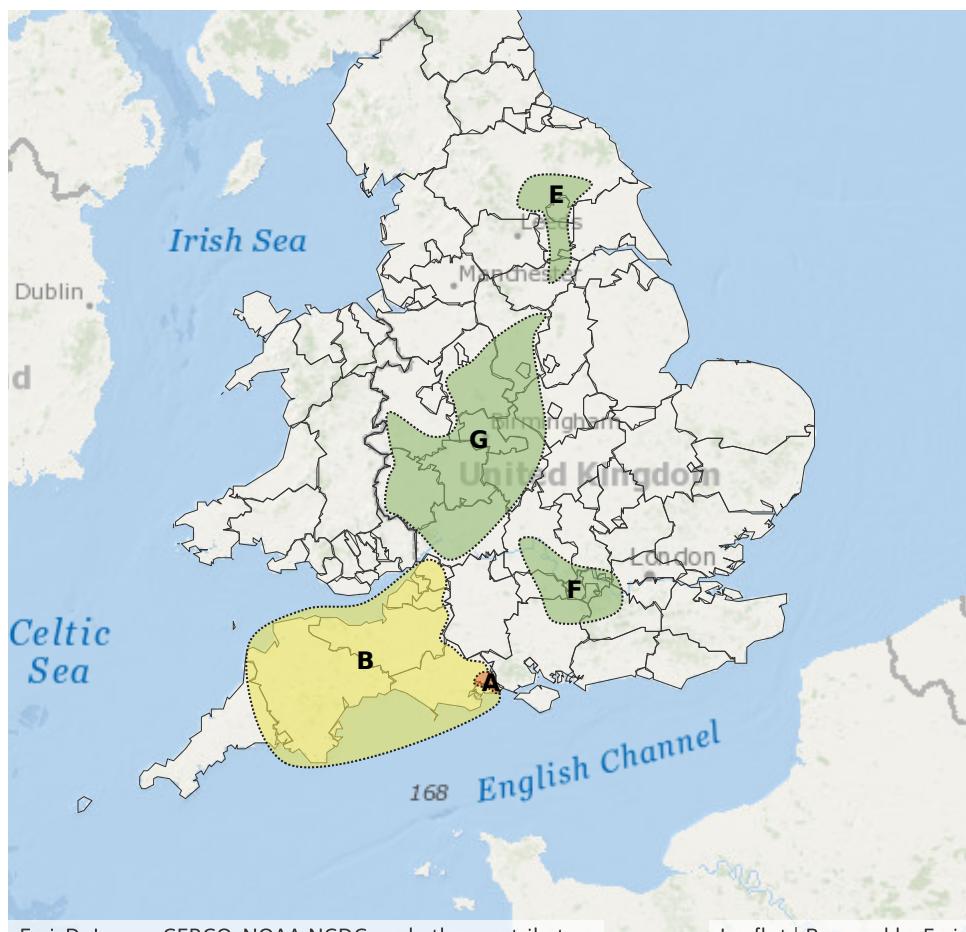

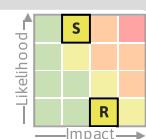

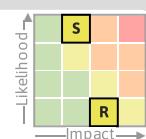

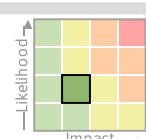

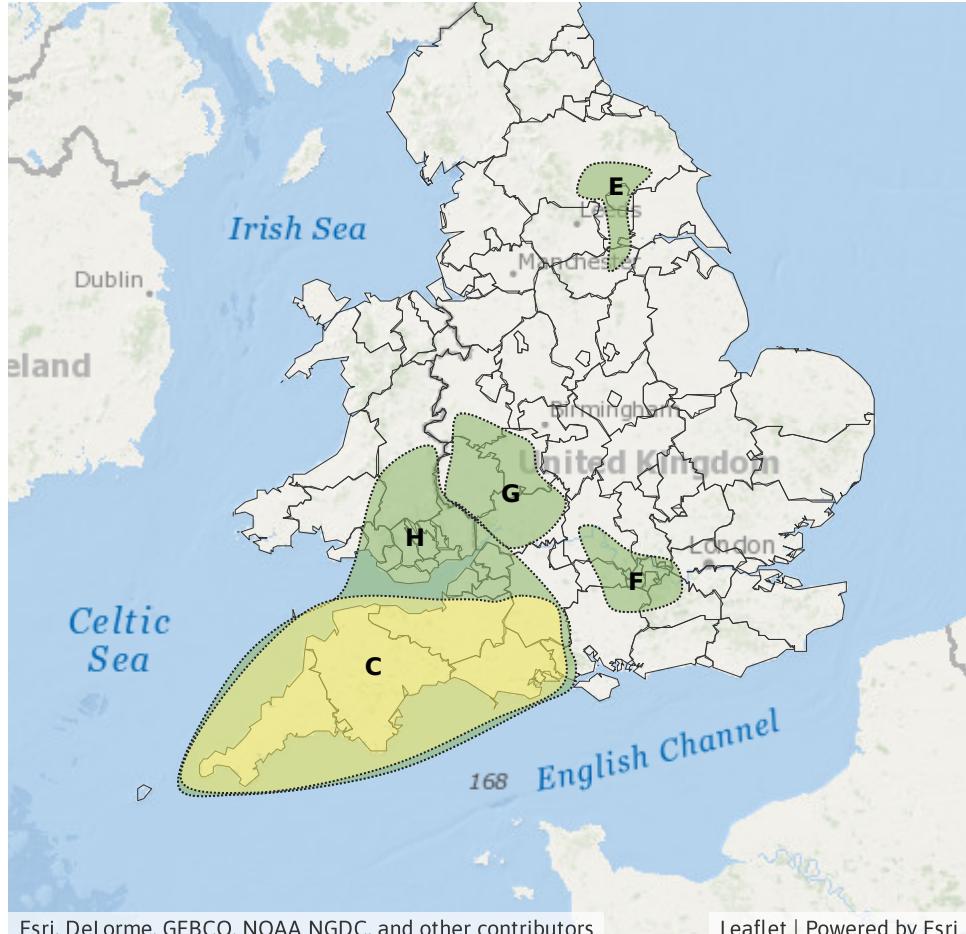

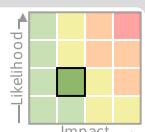

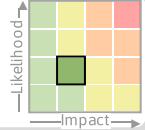

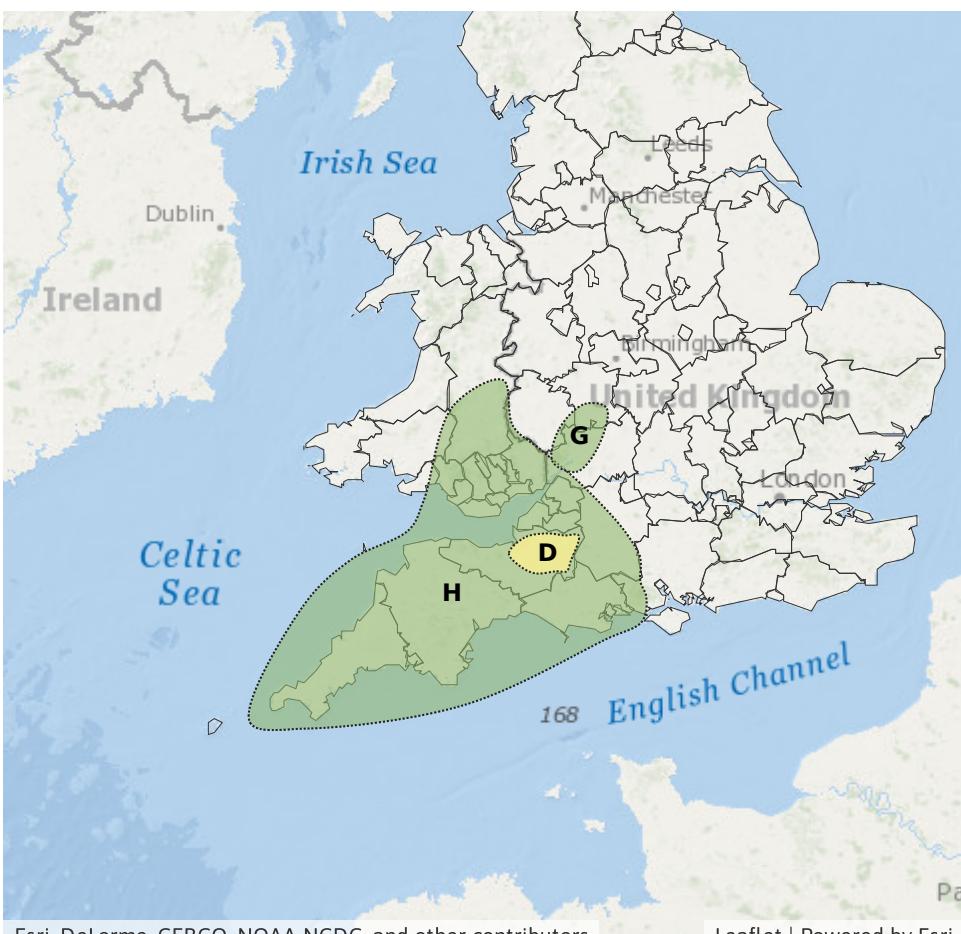

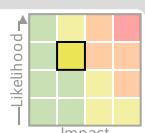


Specific Areas of Concern Map 4 - Saturday 31 January and Sunday 1 February 2026

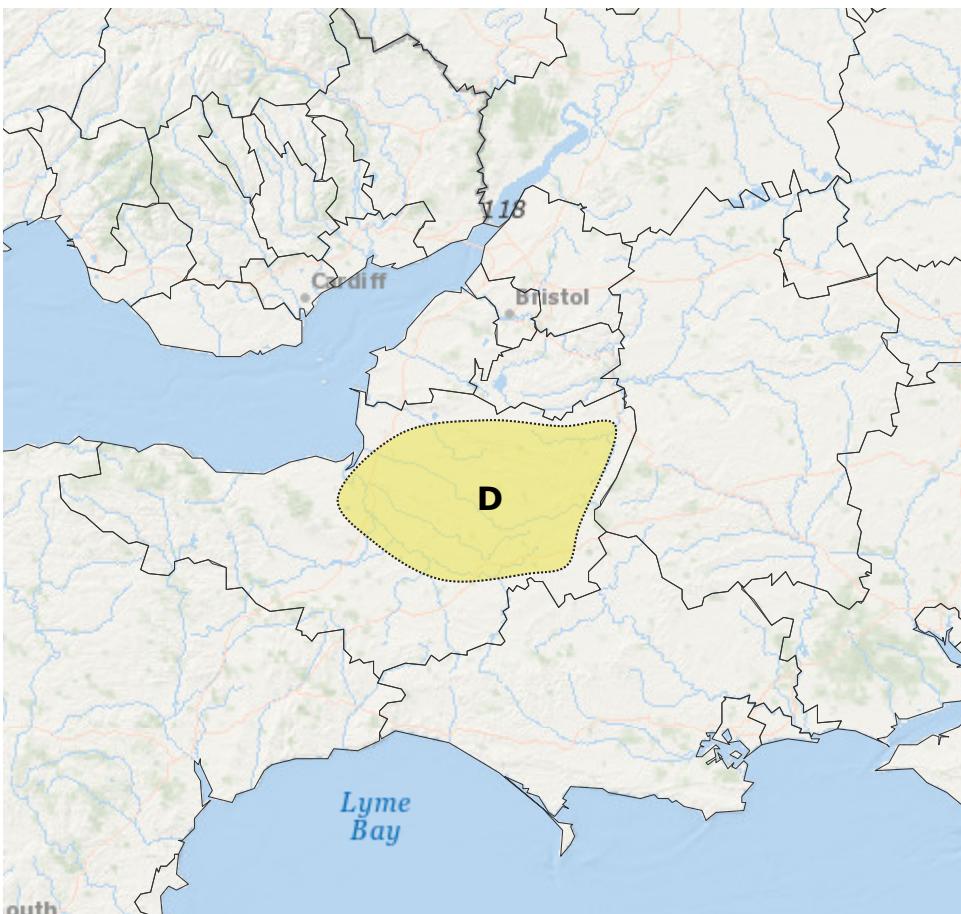

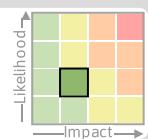

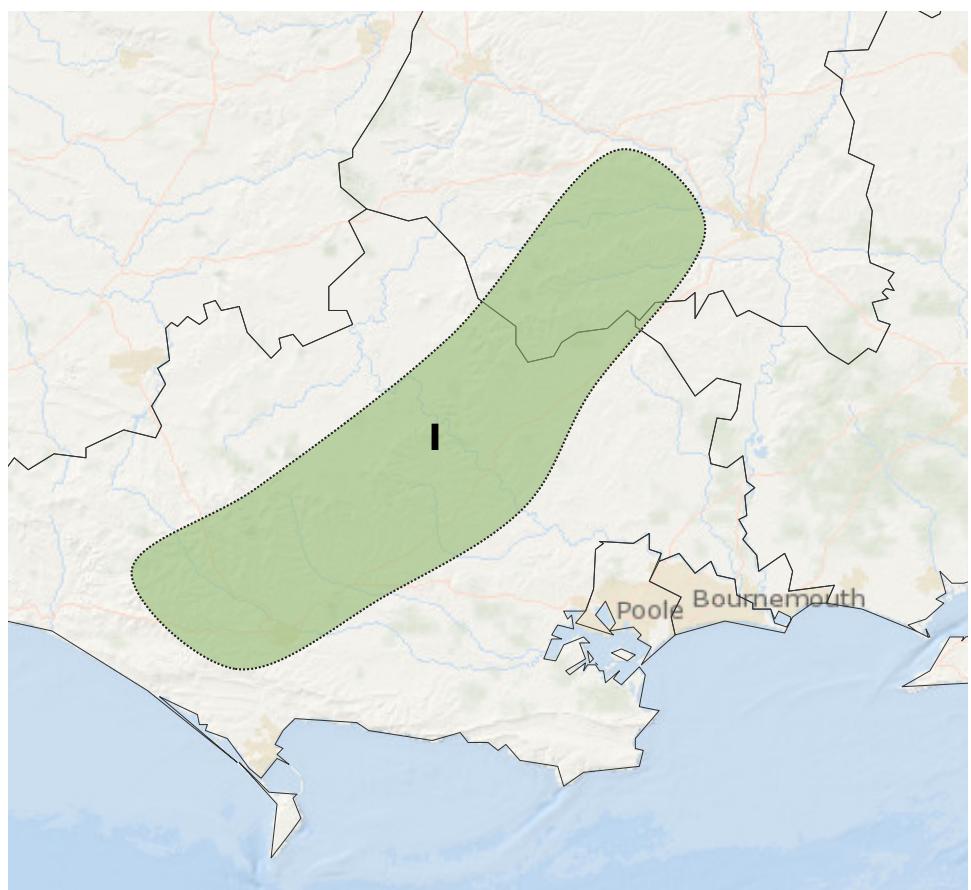

Assessment of flood risk



Rivers

The river flood risk is MEDIUM today (Wednesday).

Significant river flooding impacts are probable in parts of the South of England today. Significant river flooding impacts are also possible but not expected in parts of England on Thursday and into early Friday morning.

Minor river flooding impacts are probable across parts of the South of England from today until Sunday.

Minor river flooding impacts are possible elsewhere across parts of England from today until Friday, and for parts of Wales on Thursday and Friday.

Minor river flooding impacts are also possible but not expected more widely across parts of England and Wales today, and for parts of England on Saturday.



Surface water

The surface water flood risk is LOW on Thursday and into early Friday.

Minor surface water flooding impacts are expected for parts of England on Thursday and into early Friday morning. Minor surface water flooding impacts are also possible on Thursday and Friday elsewhere in parts of England and Wales, and possible but not expected for parts of England on Saturday.

Impacts could include localised flooding from urban and fast responding smaller watercourses/catchments, drains, channels and flooding from overland flow.



Groundwater

The groundwater flood risk is VERY LOW for the next five days.

Minor groundwater flooding impacts are possible from today. See Areas of Concern Map.



Coastal/Tidal

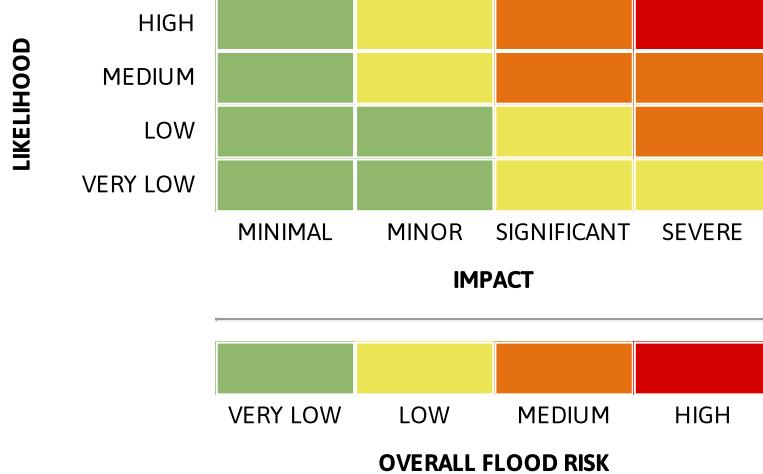
The coastal/tidal flood risk is VERY LOW for the next five days.

Minimal coastal impacts are possible along some English coasts on Friday and Saturday due to large waves. Impacts may include isolated spray on low-lying roads and coastal promenades.

6-10 day forecast

Unsettled conditions are expected to continue with further low pressure systems from the southwest. Areas that have seen the most rainfall recently are those most likely to see further heavy rain during this period. This could lead to significant inland flooding impacts.

Flood risk matrix



Summary of potential impacts

MINIMAL

Isolated and minor flooding of low-lying land and roads
Isolated spray/wave on coastal promenades
Little or no disruption to travel, but wet road surfaces

MINOR

Localised flooding of land and roads
Flooding affecting individual properties
Disruption to travel and key sites in flood plans

SIGNIFICANT

Flooding affecting parts of communities
Possible danger to life and damage to buildings/structures
Disruption to travel and key sites in flood plans

SEVERE

Danger to life, severe disruption to travel
Widespread flooding affecting whole communities
Widespread disruption or loss of infrastructure
Large scale evacuation of properties possible
